- Commissioner Bierbaum asked Chief Roman if he can arrange a drill to clean out the gutters at the substation. Engineer McCann suggested not putting more than one person on the roof at one time. Chief Roman said he can arrange that.

#### <u>Silverton Report</u> – Chief Sinnott reported the following:

- They had a couple of meetings with Ocean County College's new director regarding future drills.

### <u>Pleasant Plains report</u> – Chief Roman reported the following:

• Everything is up and running

- His is waiting for 2905 to come back in service; they sent 3065 out for repairs, and it will probably be out of service for a couple of days.
- They got nine new members in the last month and a half; two are already qualified; they will have seven going to the Academy for Firefighter Level I & II
- They have no trucks going to Wildwood; however, they would like to have permission to take 3017 to tow the trailer
- They had 629 calls as of July 31st

<u>Business Administrator Report</u> – Business Administrator Gargano gave the following report:

- o New Applicants We have a few applicants in the process.
- o NFPA Physicals Firefighters have just three more weeks to get their physicals
- o Sale of Vehicles Are being posted on govdeals.com. Once govdeals is ready, I will advertise and give govdeals the dates.
- Pump Testing: Monday, October 28<sup>th</sup>
   Tuesday, October 29<sup>th</sup>
- EZ Pass Transponders in 2913 and 2931 Need the number of the transponder that is in each vehicle to avoid violations
- o Actuarial Report for Postretirement Benefits was completed and submitted to the auditor. Next year, the cost for the actuarial services will only be \$500.
- o Psych Evals Commissioner Duff installed the computer and monitor. Psych Evals are now being done on the computer.

### **Unfinished Business:**

<u>Opti-Coms</u> – Commissioner Bierbaum asked if anyone had an updated status on the opti-coms. Business Administrator Gargano reported that we issued the purchase orders for the opti-coms. Commissioner Bierbaum reported that he will contact Commissioner Silva regarding the opti-coms.

#### **New Business:**

Aerial Inspection of 2905 – Commissioner Geoghegan reported that ERS was the lowest quote. Chief Sinnott stated that he would like an authorized Rosenbauer dealer to perform the work. Commissioner Duff suggested contacting P & L. Commissioner Britton advised that the contract that Pleasant Plains has for their aerial inspection is with Sutphen, and Sutphen contracts out with Blaze; he suggested finding out if Rosenbauer will provide a contract for the aerial inspection.

<u>Grant Writing</u> – Commissioner Bierbaum stated that previously Commissioner Duff advised us that there was a gentleman who does grant writing; Commissioner Bierbaum suggested that we schedule a meeting with this person to investigate whether there are any grants out there on equipment or anything else.

<u>Work Session Meeting</u> – Commissioner Bierbaum suggested having a work session meeting with the officers of each fire company after the second meeting of the month. Chief Sinnott said there are topics that can be discussed. Commissioner Bierbaum asked the chiefs to check their schedules, and asked if any other fire commissioner wanted to attend these meetings.

EMS Ambulance Assigned to the Fire Academy – Commissioner Bierbaum suggested that we have an EMS ambulance permanently assigned to the Fire Academy – something fully equipped and ready to go so that if anyone gets injured during any of the evolutions,

they can be treated and transported expeditiously; there are many instructors who are EMTs at the Fire Academy. Commissioner Bierbaum reported that he discussed this with Pleasant Plains First Aid Squad Captain Monaco and Silverton EMS Business Administrator Geoghegan; this is to be brought up at the joint board meeting.

Conflict in being a Fire Commissioner and Fire Officer Simultaneously – Commissioner Duff reported that he received a letter from DCA regarding a complaint against him serving as Treasurer to Silverton Vol. Fire Company and as Fire Commissioner simultaneously; DCA found him not to be in conflict, but they stated that there would be a conflict if a fire officer of the fire company were simultaneously serving as a Fire Commissioner due to recommendations being made by fire officers for purchases. Commissioner Duff stated that he agrees that we should eliminate any fire officer from serving as a Fire Commissioner simultaneously, as well as excluding the treasurer of the fire company from being a fire commissioner. Commissioner Britton said we always had the intention to exclude all fire officers from being eligible to be fire commissioner. Commissioner Geoghegan said we could have firefighters on a truck committee making recommendations, as well; and he feels we have already addressed this issue. Commissioner Bierbaum said it is a valid point to be considered, should be tabled at this time, and warrants further discussion.

<u>Closed Session</u> – A resolution was introduced by Mr. Bierbaum, seconded by Mr. Duff to go into closed session at 8:02 p.m..
